To all members of the Chamber,

It is a pleasure to celebrate the milestone of the 30-year anniversary of the British Chamber of Commerce in Taipei this year. I am grateful for the invaluable partnership and collaboration between the Chamber and the British Office Taipei during this time, and for the Chamber's three decades of dedication to building a community for international businesses in Taiwan.

Taiwan's economy is set for a robust spell of growth this year, recovering from a sluggish 2023 that saw slow global growth limit demand for Taiwan's high-tech exports. Growth in 2024 is expected to pick up to around 3.3-3.4%, buoyed by strong demand for AI and other technology products.

For the British Office Taipei, 2023 was a fantastic year.

We not only expanded the team but also saw the continued strengthening of our trade ties across academic, technology, investment, market access and the clean energy transition - to name but a few areas of our work.

Last year the UK and Taiwan signed an Enhanced Trade Partnership (ETP) Arrangement, which sets out our shared vision and priorities for deepening our bilateral trade and investment relations. The ETP focuses on three key areas: bilateral investment, digital trade, and renewable energy & net-zero, with the option to expand to new areas in future. It is a partnership that will create new opportunities and benefits for businesses and consumers in both Taiwan and the UK.

The ETP has already delivered economic value for the UK, with several high-profile Taiwanese investments into the UK tech sector announced this year, including significant investments from MediaTek Venture Capital and TCVC in UK innovation.

Achieving net-zero by 2050 is a mutual goal of the UK and Taiwan. Offshore wind installed capacity in Taiwan has now reached 2.37 GW with 297 turbines installed this year, and we continue to share UK experience and best practice in offshore wind development with Taiwan.

British companies have played a key role in offshore wind deployment here and the UK has provided financial guarantees for offshore wind developments in Taiwan through UK Export Finance –supporting four projects totalling £900 million since 2019.

We value the cooperation of the UK Renewables Committee (UKRC) representing British offshore wind companies in Taiwan. Together we delivered a successful UK Pavilion at Energy Taiwan for the fifth consecutive year last year last year.

In the Food & Beverage sector, we secured market access for British lamb to Taiwan, a market we estimate is worth £35m over the next 5 years and we have signed an MOU with Taiwan on organics equivalence which will introduce British organic products to Taiwanese consumers.

With the Chamber's commitment to support British businesses, I am confident that the British business community will be able to capitalise on ever more commercial opportunities in Taiwan. The British Office Taipei looks forward to working with the new Chair, Vice Chair and BCCT Board in the year ahead.






2023 was a positive year financially, with record annual revenue driven by sponsorship income and increased mission-related revenue. Our participation in the Energy Taiwan exhibition significantly bolstered our trade promotion success. Revenue from both large and small corporate membership fees remained crucial, despite a decline in joining fees reflecting a temporary slowdown in membership growth. Our members' steadfast support highlights their commitment to our Chamber and its initiatives. Although event participation was robust, ticket sales for the St. Andrew's Ball were below expectations.

From 2022 to 2023, we observed a notable increase in the cost of sales due to higher venue and subcontractor costs, wages, and rent. Despite these challenges, our ability to maintain stable operating expenses reflects our effective cost management. This robust financial oversight helped us navigate increased sales activities without sacrificing fiscal health. The net deficit for the year was attributed to these higher costs and a reclassification of previous years' prepayment expenses identified in the 2023 audit.

BALANCE SHEET

Our balance sheet for 2023 remained healthy, with a decrease in assets primarily due to the payment of accrued charitable donations, showcasing our continued commitment to supporting CSR initiatives. Despite some fluctuations, our financial position remained stable, demonstrating resilience and a solid foundation for future growth.
